



*BAC Resolution No. 2024-0910-222 (Bravo)*

**SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF METEOROLOGICAL INSTRUMENT FOR CATBALOGAN AIRPORT**

**WHEREAS**, the project Supply and Delivery of Meteorological Instrument for Catbalogan Airport, an ANS project, was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to Nine Million Seven Hundred Seventy-Eight Thousand Seven Hundred Ninety-Eight Pesos & 61/100 (**Php 9,778,798.61**). A copy of the Certificate of Budget Allocation (CAR No. 2023-12-052 dated 11 December 2023) is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement was on 30 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 24 September 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, Pre-bid Conference was conducted on 02 October 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, Bid Bulletin No. 01 dated 08 October 2024 was issued for some clarification/revision/amendments in the bidding documents of the project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

**WHEREAS**, Bid Bulletin No. 02 dated 09 October 2024 was issued for was issued for the re-scheduling of the Opening and Submission of Bids to 25 October 2024. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "F"*;

**WHEREAS**, a Notice of Postponement was issued dated 25 October, 2024 re-scheduling the Submission and Opening of Bids to 28 October 2024, due to inclement weather. A copy of the Notice of Postponement is hereto attached as *Annex "G"*;

**WHEREAS**, on 28 October 2024, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting is hereto attached as *Annex "H"*;

**WHEREAS**, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when no bids are received"*;


