



BAC Resolution No. 2024-0910-255 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF METEOROLOGICAL INSTRUMENT FOR CATBALOGAN AIRPORT (RE-BID)

WHEREAS, in a BAC Resolution No. 2024-0910-222 dated 15 November 2024, The Bids and Awards Committee- Bravo declared the bidding for the project a failure. A copy of BAC Resolution No. 2024-0910-222 is herein attached and made an integral part of this Resolution as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 30 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 30 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 06 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 18 November 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 20 November 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of Domestic Trading Corporation. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H", respectively*;



WHEREAS, the Committee issued a letter to Domestic Trading Corporation., dated 22 November 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "I"*;

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 04 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of **Domestic Trading Corporation.** be declared as Single Calculated Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **Nine Million Seven Hundred Seventy-Eight Thousand Seven Hundred Ninety-Eight Pesos (PHP9,778,798.00)**. The copy of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively*;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project **Domestic Trading Corporation.**, in the amount of **Nine Million Seven Hundred Seventy-Eight Thousand Seven Hundred Ninety-Eight Pesos (PHP9,778,798.00)**.

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

NOW THEREFORE, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Supply and Delivery of Meteorological Instrument for Catbalogan Airport (Re-Bid) in the amount of **Nine Million Seven Hundred Seventy-Eight Thousand Seven Hundred Ninety-Eight Pesos (PHP9,778,798.00)** to **Domestic Trading Corporation.**
