



BAC Resolution No. 2024-0910-267 (Bravo)

SUBJECT:

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF RADIATORS, PULLEYS AND BATTERY CHARGERS FOR **80KVA AKSA DEGS AT VARIOUS CNS/ATM RADAR SITES**

WHEREAS, the project, Supply and Delivery of Radiators, Pulleys and Battery Chargers for 80KVA AKSA DEGS at Various CNS/ATM Radar Sites, an ANS project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippine14s (CAAP-BAC Bravo) for its procurement. The project has an approved budget of One Million Four Hundred Five Thousand Forty Pesos (PHP1,405,040.00). A copy of the Certificate of Budget Allocation CBA (MOOE) 24-09-1114 dated 06 September 2024 is herein attached as Annex "A";

WHEREAS, the Pre-Procurement Conference was conducted on 04 October 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as Annex "B";

WHEREAS the Invitation to Bid (ITB) was posted on 30 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as Annex "C";

WHEREAS, the Pre-bid Conference was conducted on 08 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "D";

WHEREAS, Bid Bulletin No. 01 was issued dated 18 November 2024 wherein the new schedule for the Submission and Opening of Bids will be set on 27 November 2024. A copy of Bid Bulletin No.01 is hereto attached as Annex "E";

WHEREAS, the Submission and Opening of Bids for the project was held on 27 November 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as Annexes "F" & "G", respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 28 November 2024 and was presented to the BAC on 29 November 2024 where it is indicated that the tendered bid proposal of Trade Venture International Corporation to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "H" & "I", respectively;

WHEREAS, the Committee issued a letter to Trade Venture International Corporation, dated 29 November 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "J";

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 11 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of Trade Venture International Corporation. be declared as Single Calculated Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of One Million Three Hundred Ninety-Eight Pesos (PHP1,398,000.00). The copy of said Report and Minutes of Meeting are hereto attached as Annexes "K" & "L", respectively.;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project Trade Venture International Corporation, in the amount of One Million Three Hundred Ninety-Eight Pesos (PHP1,398,000.00).

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Supply and Delivery of Radiators, Pulleys and Battery Chargers for 80KVA AKSA DEGS at Various CNS/ATM Radar Sites in the amount of One Million Three Hundred Ninety-Eight Pesos (PHP1,398,000.00) to Trade Venture International Corporation.
