



BAC Resolution No. 2024-0910-230 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF SELF-CONTAINED BREATHING APPARATUS REFILLING MACHINE FOR VARIOUS AIRPORTS.

WHEREAS, the project, Supply and Delivery of Self-Contained Breathing Apparatus Refilling Machine for Various Airports, an ADMS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to Two Million Seven Hundred Sixteen Thousand Pesos (PHP2,716,000.00). A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-07-926 dated 17 July 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 19 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 24 September 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 02 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Bid Bulletin No. 01 dated 09 October 2024 was issued for the new schedule of the Submission and Opening of Bids. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

WHEREAS, the Committee issued a new Bid Bulletin No. 02 on 28 October 2024, which contained a response to the clarification letter of Renlette Trading and a new schedule for the Submission and Opening of the Bids for this project. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 04 November 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H", respectively*;

WHEREAS, the Bids and Awards Committee - Technical Working Group (BAC-TWG Bravo) issued its Bid Evaluation Report dated 06 November 2024 and was presented to the BAC on 08 November 2024, where it is indicated that the calculated bid proposal of Renlette Trading is hereby recommended to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "I" & "J", respectively*;

WHEREAS, the Committee issued a letter to Renlette Trading dated 08 November 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "K"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 27 November 2024 and was presented to the BAC on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of Renlette Trading be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Two Million Four Hundred Ninety-Four Thousand Three Hundred Fifty Pesos (PHP2,494,350.00). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "L" & "M", respectively*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRБ, or SRRB after the post-qualification process has been completed.*;

NOW, THEREFORE, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Supply and Delivery of Self-Contained Breathing Apparatus Refilling Machine for Various Airports in the total amount of Two Million Four Hundred Ninety-Four Thousand Three Hundred Fifty Pesos (**PHP2,494,350.00**) to **Renlette Trading**.
