



BAC Resolution No. 2024-0910-247 (Bravo)

SUBJECT: RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, SUPPLY AND INSTALLATION OF FORTY-NINE (49) UNITS 2 HP INVERTER WALL MOUNTED SPLIT TYPE AIRCON UNITS AT CAAP CENTRAL

WHEREAS, the project Supply and Installation of Forty-Nine (49) Units 2 HP Inverter Wall Mounted Split Type Aircon Units at CAAP Central, a BGMS project, was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of **Three Million Eight Hundred Twenty-Two Pesos (Php 3,822,000.00)**. A copy of the Certificate of Budget Allocation CBA (C.O.) #24-05-660, dated 23 May 2024, is attached hereto as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 21 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 06 November 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 13 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 25 November 2024 at the CAAP Conference Room via in-person meeting and video conference. Bidders submitted their bid proposals for the project and the following results were noted. The copies of the Minutes of the Meeting and Abstract of Bids as read are hereto attached as *Annexes "E" & "F"*, respectively;

WHEREAS, the Committee received a Request for Reconsideration from Paulen General Merchandise dated 25 November 2024 asking the Committee to re-submit their missing attachment from their bid. A copy of the Request for Reconsideration is hereto attached as *Annex "G"*;

WHEREAS, the Committee issued its reply to the Request of Reconsideration of Paulen General Merchandise sent via electronic mail on 25 November 2024. A copy of the reply to the Request for Reconsideration is hereto attached as *Annex "H"*;

WHEREAS, the BAC Technical Working Group (Bravo) issued its Bid Evaluation Report, dated 26 November 2024, and presented it to the BAC on 27 November 2024, indicating that the tendered bid proposal of MJL Enterprises. should undergo the post-qualification process for being evaluated and considered as the Lowest Calculated Bid (LCB). The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "I" & "J"*, respectively;

WHEREAS, the Committee issued a letter to MJL Enterprises., dated 28 November 2024, requiring them to submit the requirements for post-qualification. A copy of the letter is hereto attached as *Annex "K"*;

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report, dated 06 December 2024, and presented it to the BAC Committee (Bravo) on 09 December 2024, wherein the BAC TWG (Bravo) recommended that the bid proposal of **MJL Enterprises**. be declared as the Single Calculated Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **Three Million Six Hundred Forty-Nine Thousand Six Hundred Eighteen Pesos (Php 3,649,618.00)**. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "L" & "M"*, respectively;

WHEREAS, Section 37.1.1 of the 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of the contract to the bidder with the LCRB, HRRB, SCRБ, or SRRB after the post-qualification process has been completed;*

NOW, THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of the BAC-TWG (Bravo), hereby **RESOLVES** to **RECOMMEND TO AWARD THE CONTRACT** for the project **Supply and Installation of Forty-Nine (49) Units 2 HP Inverter Wall Mounted Split Type Aircon Units at CAAP Central** in the amount of **Three Million Six Hundred Forty-Nine Thousand Six Hundred Eighteen Pesos (Php 3,649,618.00)** to **MJL Enterprises**.
