



BAC Resolution No. 2024-0910-218 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, SUPPLY OF TECHNICAL SERVICES FOR THE UPDATING AND PREPARATION OF ELECTRICAL AS-BUILT PLAN OF THE PHILIPPINE ATM CENTER

WHEREAS, the project Supply of Technical Services for the Updating and Preparation of Electrical as-built Plan of the Philippine ATM Center, an ANS project, was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **One Million Eight Hundred Twenty-Eight Thousand Nine Hundred Fifteen Pesos (Php1,828,915.00)**. A copy of the Certificate of Budget Allocation (CBA (C.O) No. 24-08-1021 dated 12 August 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 23 September 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 14 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, Pre-bid Conference was conducted on 21 October 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, on 04 November 2024, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting is hereto attached as *Annex "E"*;

WHEREAS, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when no bids are received"*;

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **Supply of Technical Services for the Updating and Preparation of Electrical as-built Plan of the Philippine ATM Center** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review;


