## RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT SUBJECT: ENTITLED, UPGRADE OF THE EXISTING ARCHIVE SYSTEM AND MAINTENANCE OF AVIATION RECORD MANAGEMENT DIVISION

WHEREAS, the project Upgrade of Existing Archive System and Maintenance of Aviation Record Management, an RSD-FSIS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to One Million Two Hundred Fifty Thousand Pesos (PHP1,250,000.00). A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-05-624 dated 15 May 2024) is herein attached as Annex "A";

WHEREAS, the Pre-Procurement Conference was on 19 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "B";

WHEREAS, the Invitation to Bid (ITB) was posted on 24 September 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as Annex "C";

WHEREAS, Pre-bid Conference was conducted on 02 October 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "D";

WHEREAS, The Committee issued a Bid Bulletin No. 01 dated 09 October 2024, which contained the new schedule for Submission and Opening of Bids. A copy of the Bid Bulletin No. 01 is hereto attached as Annex "E";

WHEREAS, a Notice of Postponement was issued dated 25 October 2024, suspending all BAC proceedings due to inclement weather. A copy of the Notice of Postponement is hereto attached as Annex "F";

WHEREAS, the Submission and Opening of bids for the project was held on 28 October 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as Annexes "G" & "H", respectively;

WHEREAS, the Committee received a Request for Reconsideration from Kiranet Inc. dated 28 October 2024, stating their reasons for failing to attach an updated Tax Clearance Certificate. A copy of their Request for Reconsideration is hereto attached as Annex "!";



**WHEREAS**, during the BAC Bravo regular meeting on 30 October 2024, the Request for Reconsideration of Kiranet Inc. was discussed to the Committee, where the BAC TWG presented their reply and recommended for the denial of the Request for Reconsideration and declare the failure of the bidding as stated in Sec 35.1 (b) of RA 9184. The copy of the reply is hereto attached as *Annex "J"*;

**WHEREAS**, Section 35.1 (c) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when: All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;";* 

**NOW THEREFORE**, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **Upgrade of Existing Archive System and Maintenance of Aviation Record Management Division (ARMD) Database** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review;
