**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND  
RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF GROCERY PACKS FOR THE  
YEAR – END THANKSGIVING CELEBRATION CY 2024 OF GODOFREDO P. RAMOS AIRPORT**

**WHEREAS**, BAC Resolution No. AREA6-GPR-SVP-2024-009-01 for the project **Supply and Delivery of Grocery Packs for the Year – End Thanksgiving Celebration CY 2024 of Godofredo P. Ramos Airport** with Approved Budget for the Contract (ABC) in the amount of **Fifty Six Thousand Pesos (₱ 56,000.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

**WHEREAS**, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, Two (2) interested suppliers submitted its sealed quotation;

**WHEREAS**, during the Bid Opening last December 13, 2024, **ILOILO SUPERMART INC.** was declared Single Submitted Quotation with the Bid amount of **Forty Four Thousand Eight Hundred Ninety Six Pesos & 60/100 (₱ 44,896.60)**;

**WHEREAS**, bid submitted by **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** has been disqualified due to:

a) Non-submission of eligibility requirements as stated in the Request for Quotation:

1. **Business Permit,**
2. **Certificate of Accreditation from DENR,**
3. **Omnibus Sworn Statement and**
4. **Special Power of Attorney**

In Section 30.1. of the 2016 revised IRR of RA No.9184 *"The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed.";*

b) **The bid amount exceeded the Approved Budget Contract** as stated in the Request for Quotation Terms and Condition Item No. 8: *"Quotations exceeding the Approved Budget of Contract shall be rejected."*

**WHEREAS**, the price quotation of the bidder was found to be substantially compliant:
