## CCC Resolution No. 2024-133

SUBJECT:

SUPPLY, DELIVERY AND INSTALLATION/REPLACEMENT OF ONE (1) UNIT DSE 8660 ATS MAINS CONTROLS MODULE AT MANILA CNS/ATM POWER PLANT.

WHEREAS, Purchase Request/POW/CBA No. 24-09-1111 dated 05 September 2024 for the Supply, Delivery and Installation/Replacement of one (1) unit DSE 8660 ATS Mains Controls Module at Manila CNS/ATM Power Plant with a total budget of P393,932.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 27 November 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, BAC Resolution No. 2024-0910-185 dated 20 September 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as **Annex C**;

**WHEREAS**, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 14 December 2024, Copy of PhilGeps postings hereto attached as **Annex D**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

- 1. TRADE VENTURE INTERNATIONAL CORPORATION;
- 2. ULY TECH TRADING;
- 3. KILTON MOTOR CORPORATION; and
- 4. TRIPLE A POWERTECH AUTOMATION SYSTEM INC.;

**WHEREAS**, during the opening of the sealed quotations held on 19 December 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

WHEREAS, the end-user evaluation report submitted on 27 December 2024 disclosed that APPLIED SYSTEMS MANUFACTURING CORPORATION complied with all CAAP requirements and specifications and is considered the lowest calculated and responsive quotation. Copy of the Evaluation hereto attached as Annex E;

**WHEREAS,** Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL the Supply, Delivery and Installation/Replacement of one (1) unit DSE 8660 ATS Mains Controls Module at Manila CNS/ATM Power Plant in the total amount of TWO HUNDRED ONE THOUSAND PESOS (P201,000.00) only, and be AWARDED to APPLIED SYSTEMS MANUFACTURING CORPORATION, the offer of which was considered reasonable and advantageous to the Government;
