**PROCUREMENT OF ONE (1) YEAR MANPOWER OUTSOURCING CONTRACT FOR THE
PROVISION OF GENERAL SUPPORT SERVICES FOR CAAP HEAD OFFICE AND AREAS
NATIONWIDE**

THIS AGREEMENT entered this JAN 30 2025 between
CIVIL AVIATION AUTHORITY OF THE PHILIPPINES with office address at Old MIA Road
corner Ninoy Aquino Avenue, Pasay City 1300 created under Republic Act 9497 hereinafter
called "CAAP" and represented herein by **CAPTAIN MANUEL ANTONIO L. TAMAYO** in his
capacity as Director General of the one part:

LSERV CORPORATION., a corporation organized and existing by virtue of law and
with office address at 21st Floor, Petron Mega Plaza, 358 Sen. Gil Puyat Avenue, Makati City
hereinafter called "the Supplier" and represented herein by **JOSEPH V. ANGELES** in his
capacity as President of the other part.

WHEREAS, CAAP requested quotation for certain ancillary services, particularly the
*Procurement of One (1) Year Manpower Outsourcing Contract for the Provision of General
Support Services for CAAP Head Office and Areas Nationwide* and has accepted the
Quotation by the Supplier for the supply of those services in the sum of **SIX HUNDRED ONE
MILLION ONE HUNDRED ONE THOUSAND SIX HUNDRED FIFTEEN PESOS & 06/100 ONLY**
(Php601,101,615.06) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

In consideration of the sum of **SIX HUNDRED ONE MILLION ONE HUNDRED ONE THOUSAND SIX HUNDRED FIFTEEN PESOS & 06/100 ONLY (PHP601,101,615.06)** or such other sums as may be ascertained, **LSERV CORPORATION**, agrees to service the *Procurement of One (1) Year Manpower Outsourcing Contract for the Provision of General Support Services for CAAP Head Office and Areas Nationwide* in accordance with his/her/its Bids.

4. In consideration of the provision of the services within **One (1) Year** and the remedying of defects thereof, CAAP hereby covenants to pay the supplier the Contract Price or such other sum as may become payable under the provision of the Agreement at the times in the manner prescribed by this Agreement.
