c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.	Thirty percent (30%)



Failure to enter into the said contract or provide the required Performance Security Bond shall disqualify the bid of **LSERV CORPORATION** and shall render this notice canceled.


