CCC Resolution No. 2024-114

SUBJECT:

SUPPLY AND DELIVERY OF AVIATION HEADSETS FOR JET TYPE AIRCRAFT.

WHEREAS, Purchase Request/POW/CBA No. 24-09-1209 dated 24 September 2024 for the Supply and Delivery of Aviation Headsets for Jet Type Aircraft with a total budget of P124,317.32 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 18 October 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". Copy of the minutes hereto attached as Annex B;

WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 31 October 2024, no quotation was received by the CCC Secretariat. The project was re-posted on 16 November 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

- 1. AIRPARTS ENTERPRISES;
- 2. SKY AEROTRADE VENTURES COMPANY;
- 3. PROFESSIONAL AIR MAINTENANCE SERVICES;
- 4. GOLDICHI INDUSTRIAL TRADE; and
- 5. WINGS TECHNOLOGY ENTERPRISES ENTERPRISE, INC.

WHEREAS, during the opening of the sealed RFQs held on 27 November 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

WHEREAS, the end-user evaluation report submitted on 04 December 2024 disclosed that AIRPARTS ENTERPRISES complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as Annex D;

WHEREAS, Annex "H" of the Revised RR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of Aviation Headsets for Jet Type Aircraft in the total amount of ONE HUNDRED EIGHTEEN THOUSAND EIGHT HUNDRED SIXTEEN PESOS (P118,816.00) only, and be AWARDED to AIRPARTS ENTERPRISES, the offer of which was considered reasonable and advantageous to the Government;
