

CCC Resolution No. 2024-115

SUBJECT: SUPPLY AND DELIVERY OF PORTABLE AVIATION GPS.

WHEREAS, Purchase Request/POW/CBA No. 24-09-1238 dated 27 September 2024 for the Supply and Delivery of Portable Aviation GPS with a total budget of P284,585.03 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 18 October 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". Copy of the minutes hereto attached as **Annex B**;

WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 31 October 2024, no quotation was received by the CCC Secretariat. The project was re-posted on 16 November 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

- 1. AIRPARTS ENTERPRISES;
- 2. SKY AEROTRADE VENTURES COMPANY;
- 3. PROFESSIONAL AIR MAINTENANCE SERVICES;
- 4. GOLDICHI INDUSTRIAL TRADE; and
- 5. WINGS TECHNOLOGY ENTERPRISES ENTERPRISE, INC.

WHEREAS, during the opening of the sealed quotations held on 27 November 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

WHEREAS, the end-user evaluation report submitted on 04 December 2024 disclosed that SERVO AEROTRADE SERVICES, INC. complied with all CAAP requirements and specifications and is considered as the lowest calculated and responsive quotation. Copy of the Evaluation Report hereto attached as **Annex D**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby RESOLVED to recommend for **APPROVAL** of the Supply and Delivery of Portable Aviation GPS in the total amount of **TWO HUNDRED SIXTY-EIGHT THOUSAND PESOS (P268,000.00)** only, and be **AWARDED** to **SERVO AEROTRADE SERVICES**, **INC.**, the offer of which was considered reasonable and advantageous to the Government;
