

AMENDMENT TO ORDER

This **AMENDMENT TO ORDER** is entered into on this MAR 21 2025 by and between:

The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP), a government agency created under Republic Act No. 9497, with office address at Old MIA Road corner Ninoy Aquino Avenue, Pasay City 1300 and represented herein by **LTGEN RAUL L DEL ROSARIO AFP (RET)** in his capacity as Director General, hereinafter referred to as the "Procuring Entity" or "CAAP"; and

MJL ENTERPRISES, a corporation duly organized and existing under Philippine law, with office address at 122 J. Sumulong Avenue, Bagumbayan, Teresa, Rizal, represented by **JOHNLLY GERBER C. CRUZ**, in his/her capacity as the Supplier, hereinafter referred to as the "Contractor".

WHEREAS, CAAP and the MJL Enterprises entered into a contract for the ***Supply and installation of forty-nine (49) units 2HP Inverter Wall Mounted Split Type Aircon units at CAAP Central*** (the "Contract"), with **Contract Price of Three Million Six Hundred Forty-Nine Thousand Six Hundred Eighteen Pesos Only (Php 3,649,618.00)** dated **04 February 2025**.

WHEREAS, per the Original Contract, MJL Enterprises is specifically bound to deliver **LG Electronics Philippines, Inc. ACU (HS-18ISU)** with Indoor Specification: Inverter type | Split Type | 2 HP Nominal Cooling Capacity | Energy Efficient Ratio of 11.6 kJ/hW | Outdoor Specification: R32 Refrigerant type | At least 650 grams Refrigerant Charge | Electrical Specifications: 220-230 Voltage as part of the hardware component;

WHEREAS, the Contractor has proposed an amendment to the Contract to substitute the originally specified LG Electronics Philippines, Inc. ACU (HS-18ISU) with **LG Electronics Philippines, Inc. ACU (HS-18IBA)** Indoor Specification: Inverter type | Split Type | 2 HP Nominal Cooling Capacity | Energy Efficient Ratio of 9.75 kJ/hW | Outdoor Specification: R32 Refrigerant type | At least 650 grams Refrigerant Charge | Electrical Specifications : 220-230 Voltage as the hardware to be supplied under the Contract;

WHEREAS, CAAP, as the end-user, finds the proposed substitution of hardware specifications beneficial without incurring additional costs;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, CAAP and the Contractor agree as follows:

1. Amendment to Hardware Model:

The hardware specifications in the Contract are hereby amended to replace LG Electronics Philippines, Inc. ACU (HS-18ISU) 2 HP Wall Mounted Split Type (Inverter Type).

2. Effective Date:

This Amendment shall be effective immediately upon execution by both parties.

3. **No Further Changes:**

Except as specifically amended herein, all other terms and conditions of the Contract shall remain in full force and effect. If there is conflict between this amendment and the Agreement, the terms of this Amendment will prevail.
