BEEMAX CONSUMER GOODS TRADING, a single proprietorship organized and existing by virtue of law and with office address at 273 Purok 6, Bunga, Tanza, Cavite hereinafter called "the Supplier" and represented herein by MAXIMINO P. PORCIONCULA in his capacity as Manager of the other part.

WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the *Purchase of Nine (9) units Wi-Fi Access Point and One (1) unit Cloud Controller for 2nd Floor Manila AFC Complex and has accepted the Quotation by the Supplier to the supply of those goods in the sum of ONE HUNDRED FIVE THOUSAND PESOS ONLY (Php105,000.00) hereinafter called "the Contract Price".*

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

 - (2.3) Pre-Procurement (CCC) dated 18 September 2024
 - (2.4) Formal Quotation and other attachments from the Supplier
 - (2.5) Abstract of Quotation / CCC Checklist dated 27 September 2024
 - (2.6) Evaluation Report dated 02 October 2024
 - (2.7) CCC Resolution No. 2024-079 dated 02 October 2024
- 3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within Fifteen (15) calendar days from receipt of the Notice for Compliance and to remedy defects therein in conformity in all respects with the provisions of the Contract.

Alm TAN AIN THOMAS TANNHAUSER A. FORTI 4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the *Agreement*.

5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
