

It must be present at the submission and opening of bids.
4	We would like to purchase the tender document set. Can you share online payment link or bank account information for this?	Bid documents can only be purchased in cash at the Cashiering Office, following the issuance of the Order of Payment by the BAC Secretariat.
5	Can we pay the bid security by bank transfer?	No.
6	Can we submit our bid digitally? (uploading to the system or sending by e-mail)	Bids for this project must be submitted manually; digital submissions via upload or email are not permitted.
7	Could you please inform us if there is a local institution/organisation we need to be a member of?	All bidders must secure a Philgeps Certificate of Registration Platinum Membership. In the case of a foreign bidder, a Certification from the relevant government office of their country stating that Filipinos are allowed to participate in government procurement activities for the same item or product.
