3. Bid must be complete and award will be made on a lump sum basis.
4. Price validity shall be for a period of thirty (30) calendar days.
5. The following should be submitted together with the quotation:
 - 5.1 Current Mayor's/Business Permit;
 - 5.2 Phil-GEPS Registration Number;
 - 5.3 Valid PCAB License Small B (GB-2 - Sewerage & Sewerage Treatment / Disposal Plant & System; GB-3 - Water Treatment Plant & System; with specialty - plumbing & sanitary works);
 - 5.4 List of completed similar project within the last three (3) years which must be related to maintenance / repair of Sewage Treatment Facility with attached supporting documents;
 - 5.5 List of Contractor's Equipment, including proof of ownership or certification of availability of minor tools and equipment and special tools from the lessor/vendor for the duration of the project, as the case may be; and



- 5.6 Name/credentials of proposed one (1) Chemical / Mechanical Engineer and two (2) Service Technician;

6.2 Latest Income & Business Tax Returns

6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and

6.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; Valid PCAB License Small B (GB-2 - Sewerage & Sewerage Treatment / Disposal Plant & System; GB-3 - Water Treatment Plant & System; with specialty - plumbing & sanitary works); Name/credentials of proposed Chemical / Mechanical Engineer and Service Technician; List of completed similar project; and List of Contractor's Equipment, including proof of ownership or certification of availability of minor tools and equipment and special tools from the lessor/vendor for the duration of the project, as the case may be, shall be automatically disqualified.


