WHEREAS, BAC Resolution No. AREA6-ILO-SVP-2025-003-01 for the project **Fire Prevention Awareness Program 2025 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Twenty Five Thousand Pesos (₱ 25,000.00)** hereby form the integral part of this resolution. 


