



BAC Resolution No. 2025-0910-05 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, LEASE OF VENUE FOR ATO SUMMIT MARCH 13-14

WHEREAS, the project Lease of Venue for Ato Summit March 13-14, an FSIS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **One Million Five Hundred Sixty-Two Thousand Pesos (PHP1,562,000.00)**. A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 25-02-205 dated 11 February 2025) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 19 February 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Notice of Negotiated Procurement and Request for Quotation dated 20 February 2025 to Manila Prince by the Manila Hotel, Citadines Bay City Manila, and Casa Ibarra. The copies of the Negotiated Letters and the Request for Quotation are hereto attached as *Annexes "C", "D", & "E" respectively*;

WHEREAS, the Committee received an electronic mail from Hotel Lucky Chinatown Megaworld Hotels & Resorts dated 25 February 2025 for their intention to participate for the procurement of this project. A copy of the letter is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 28 February 2025 at the CAAP Conference Room via in-person meeting and Google Meet Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H", respectively*;

Casa Ibarra	Disqualified (non-compliant to the Authorized and Duly Signed Financial Bid Form)
Hotel Lucky Chinatown	Disqualified (Expired attachment under Annex "A")

WHEREAS, the BAC TWG recommended for declaration of failure of the said project and was adopted by the Committee;

WHEREAS, Section 35.1 (b) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when all prospective bidders are declared ineligible."*



NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **LEASE OF VENUE FOR ATO SUMMIT MARCH 13-14** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review;
