  - Phil-GEPS Registration Number; 5.2
  - Valid PCAB License Small B Category C & D with Other Classification of Specialty -5.3 Painting Works;
  - List of completed similar project within the last three (3) years which must be related 5.4 to any painting/repainting of any vertical or horizontal structure located at an operational aerodrome with attached supporting documents;
  - List of Contractor's Equipment, including proof of ownership or certification of 5.5 availability of the Cargo Truck/ Delivery Truck, Applicator Machine and Kneading Machine from the lessor/vendor for the duration of the project, as the case may be; and

6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and

6.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; Valid PCAB License Small B - Category C & D with Other Classification of Specialty - Painting Works; Name/credentials of proposed Construction Foreman; List of completed similar project; and List of Contractor's Equipment, including proof of ownership or certification of availability of Cargo Truck/ Delivery Truck, Applicator Machine and Kneading Machine from the lessor/vendor for the duration of the project, as the case may be, shall be automatically disqualified.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **Online submission is not allowed and late quotations shall not be accepted.** 

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded.
