THIS AGREEMENT entered this _____ between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES** with office address at Old MIA Road corner Ninoy Aquino Avenue, Pasay City 1300 created under Republic Act 9497 hereinafter called "CAAP" and represented herein by **CAPTAIN MANUEL ANTONIO L. TAMAYO** in his capacity as Director General of the one part:

EVERCON BUILDERS AND EQUIPMENT CORPORATION, a corporation organized and existing by virtue of law and with office address at Unit 3A, No. 644 Rajah Matanda St., Tondo, Manila City hereinafter called "the Supplier" and represented herein by **MARIO ONG** in his capacity as President of the other part.

WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the **Replacement of eight (8) units Thorn PAPI Fixtures at Tacloban Airport** and has accepted the Quotation by the Supplier for the supply of those goods in the sum of **FIVE MILLION SEVEN HUNDRED FIFTY-NINE THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS & 74/100 ONLY (Php5,759,888.74)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively as assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within **Two Hundred Forty (240) Calendar Days** from receipt of the Notice to Proceed and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the *Agreement*.

5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
