RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF MATERIALS FOR REPAINTING OF PEDESTRIAN LANE AND ROAD MARKINGS IN FRONT OF PTB WITH TOTAL AREA = 120 SQUARE METER AND ADDITIONAL PARK STANDING MARKING AT APRON AREA OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. AREA6-ILO-SVP-2025-007-01 for the project Supply and Delivery of Materials for Repainting of Pedestrian Lane and Road Markings in Front of PTB with Total Area = 120 Square Meter and Additional Park Standing Marking at Apron Area of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Twenty Thousand Three Hundred Forty Five Pesos & 90/100 (P 20,345.90) hereby form the integral part of this resolution. WHEREAS, during the Bid Opening last March 21, 2025, EAJ CONSTRUCTION AND SUPPLY was declared Single Submitted Quotation with the Bid amount of Twenty Thousand Two Hundred Forty Five Pesos & 90/100 (₱ 20,245.90);
