WHEREAS, BAC Resolution No. AREA6-ILO-SVP-2025-012-01 for the project Repair and Maintenance of Ford YTO for Iloilo International Airport X1240 Tractor Mower with Approved Budget for the Contract (ABC) in the amount of Five Hundred Ninety Five Thousand Ninety Eight Pesos & 31/100 (₱ 595,098.31) hereby form the integral part of this resolution.
