BAC Resolution No. 2025-0311-18 (Bravo)

SUBJECT:

RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PROVISION OF MEALS FOR BAC AND CCC MEETINGS FOR CALENDAR YEAR 2025 (FRAMEWORK AGREEMENT)

**WHEREAS**, the project, Provision of Meals for BAC and CCC Meetings for Calendar Year 2025 (Framework Agreement), an PD project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Two Million Sixty-Four Thousand Pesos (PHP2,064,000.00). A copy of the Certificate of Budget Allocation CBA (MOOE) NO.: 25-02-277 dated 21 February 2025 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 28 February 2025 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 08 March 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS**, the Pre-bid Conference was conducted on 14 March 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "D"*;

**WHEREAS**, Bid Bulletin no. 01 was issued on 26 March 2025, stating the new schedule for the Submission and Opening of Bids. A copy of Bid Bulletin no.01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 04 April 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. No bidder submitted their proposal for the project. A copy of the Minutes of the Meeting is hereto attached as *Annex "F"*;

**WHEREAS**, the BAC-TWG Bravo recommended for declaration of failure of bidding having no bids received, the recommendation was then adopted by the Committee in accordance to Section 35 (a) of the Revised Implementing Rules and Regulation of RA 9184;

**WHEREAS**, Section 35(a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when: c) No bids received;"



NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby RESOLVED to recommend that the project, Provision of Meals for BAC and CCC Meetings for Calendar Year 2025 (Framework Agreement) be declared a FAILURE and to return the bid documents to the end-user for mandatory review;
