7. The Civil Aviation Authority of the Philippines will hold Pre-Bid Conference on **07 April 2025 @ 9:30AM** through video conferencing or webcasting via Google Meet, which shall be open to all short-listed consultants.
8. Upon payment of the bid documents, bidders must provide their respective email addresses to the BAC Secretariat. All communications, including but not limited to Notices, Resolutions, and Replies, among others, will be sent to the email address provided by the bidder/s. The date when such email was sent shall be considered the date of receipt of the bidder/s for purposes of complying with the requirements under RA 9184.
