The Civil Aviation Authority of the Philippines (CAAP), through the Committee on Fees and Charges, hereby notifies all CAAP-operated airports, area centers, and airline stakeholders of the adjustment to the Passenger Service Charge (PSC). This adjustment is being implemented in conjunction with the revision of the Airport Concession Fees and Charges.

As such, please be informed that the adjusted PSC rate will take effect for flight tickets purchased by 21 April 2025 onwards, as follows:

	INTERNATIONAL FLIGHTS (inclusive of Value Added Tax / VAT)	DOMESTIC FLIGHTS (inclusive of Value Added Tax / VAT)
International Airports	PHP900.00 or \$17.00 per passenger	PHP350.00 per passenger
Principal Class 1 Airports		PHP300.00 per passenger
Principal Class 2 Airports		PHP200.00 per passenger
Community Airports	None	PHP100.00 per passenger

Note, however, the exceptions to the PSC:

- a) Children under two (2) years of age at the time of departure.
- b) Overseas Filipino Workers (OFWs) for international flights only.
- c) Transit passengers.
- d) Passengers who are denied entry.

It is important to note that while some airports may currently be functioning outside of their original classification, the Passenger Service Charge shall be imposed in accordance with the airport's assigned classification, as detailed in Annex A.
