



*BAC Resolution No. 2025-0311-13 (Bravo)*

**SUBJECT: RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, SUPPLY/DELIVERY OF SPARE PARTS FOR JOTRON VHF AM RADIO FOR VARIOUS ANF'S**

**WHEREAS**, the Supply/Delivery of Spare Parts for Jotron VHF AM Radio for Various ANF's, an ANS project was forwarded to the Bids and Awards Committee - Bravo of CAAP (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Three Million Nine Hundred Ninety-Three Thousand and Six Hundred Pesos (PHP 3,993,600.00). A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 25-02-245 dated 17 February 2025) is herein attached as *Annex "A"*;

**WHEREAS**, the Change/Determination of Mode was conducted on 07 March 2025 where the end-user requested for the Change of Mode of Procurement from Competitive Bidding to Direct Contracting under Section 50.c under RA 9184. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Committee issued a Notice of Direct Contracting and Request for Quotation dated 07 March 2025 to Evercon Builders and Equipment Corporation. The copy of the letter is hereto attached as *Annex "C"*;

**WHEREAS** the Notice of Direct Contracting and Request for Quotation for the project was published on 12 March 2025. A copy of the Notice is hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 21 March 2025 at the 3rd Floor Supply, Procurement Bldg, CAAP and video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Bidding Checklist are hereto attached as *Annexes "E" & "F", respectively*;

**WHEREAS**, the BAC TWG (Bravo) issued its Bid Evaluation Report dated 26 March 2025 and presented it to the BAC Committee (Bravo) on the same date, wherein the BAC TWG (Bravo) recommended the bid proposal of **Evercon Builders and Equipment Corporation** be declared as the Single Calculated Responsive Quotation in the amount of **THREE MILLION, NINE HUNDRED FORTY-EIGHT THOUSAND, EIGHT HUNDRED EIGHTY PESOS (PHP3,948,880.00)**. A copy of said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H", respectively*;

**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*

**NOW THEREFORE**, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Supply/Delivery of Spare Parts for Jotron Vhf Am Radio for Various ANF's in the amount of **THREE MILLION, NINE HUNDRED FORTY-EIGHT THOUSAND, EIGHT HUNDRED EIGHTY PESOS (PHP3,948,880.00)** to **Evercon Builders and Equipment Corporation**.


