- 4. List of completed similar contracts within the last three (3) years which must be related to any vertical works with attached supporting documents;
- List of Contractor's Equipment, including proof of ownership or certification of availability of One Bagger Mixer, Concrete Vibrator, Bar Cutter, Chippin Gun, Scaffolding Set, and Minor Tools & Equipment, from the lessor/vendor for the duration of the project, as the case may be; and
- 6. Name/credentials of proposed one (1) Construction Foreman;
- 7. Other documentary requirements:
 - 7.1. Omnibus Sworn Statement

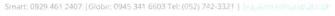

7.2. Latest Income & Business Tax Returns

- 1. Mobilization / Demobilization includes delivery of all materials and equipment's needed for the comple of the project and provision of Contractors Temporary Facility.
- 2. Provision and installation of Project Billboard for the Project to be placed at the project location.
- 3. Civil/Site Works:
 - a. Clearing and cleaning of materials and debris on the project site.
 - b. Embankment for the area of expansion same level from the existing shed and excavation worl
 - c. Preparation of areas including removal and disposal of crackled and peeled paint.
- 4. Provision of equipment shed expansion based on Plans and Details.
- 5. Painting Works:
 - a. Application of 2 coats flat latex for repainting of exterior and interior walls, garage ceiling and for the painting of shed expansion.
 - b. Application of 2 coats latex semi-gloss for repainting of exterior and interior walls, garage ceiling and for the painting of shed expansion.
