  5. List of completed similar project within the last three (3) years which must be related to preventive maintenance of air-cooled chiller and chilled water pumps with attached supporting documents;


Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **Online submission is not allowed and late quotations shall not be accepted.**
