**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL OF PURCHASE OF VEHICLE PASS STICKERS FOR 2025 OF
ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. AREA6-ILO-SVP-2025-009-01 for the project **Purchase of Vehicle Pass Stickers for 2025 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Eighty Thousand Four Hundred Thirty Pesos (P 80,430.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Three (3) interested suppliers submitted their sealed quotation;

WHEREAS, during the Bid Opening last March 21, 2025, **KOPY N' CUT PRINTING SERVICES** was declared Single Submitted Quotation with the Bid amount of **Seventy Six Thousand Nine Hundred Fifty Nine Pesos & 75/100 (P 76,959.75)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

 2. PhilGEPS Certificate of Registration (Certified True Copy)
 3. Original Notarized Omnibus Sworn Statement

In Section 30.1. of the 2016 revised IRR of RA No.9184 "The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";

WHEREAS, the detailed evaluation of quotations conducted resulted in the following:

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, **KOPY N' CUT PRINTING SERVICES** as the Supplier with the Single Calculated Responsive Quotation for the project **Purchase of Vehicle Pass Stickers for 2025 of Iloilo International Airport** in the bid amount of **Seventy Six Thousand Nine Hundred Fifty Nine Pesos & 75/100 (₱ 76,959.75);**
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
