**WHEREAS**, during the Bid Opening last April 8, 2025, **NEW ILOILO IZEEM COMMERCIAL SUMMIT, INC.** was declared Lowest Submitted Quotation with the Bid amount of **Two Hundred Twenty Six Thousand Fifty Six Pesos (₱ 226,056.45)**;
