BAC Resolution No. 2025-0311-26 (Alpha)

SUBJECT:

RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, CONSTRUCTION OF MATERIAL RECOVERY FACILITY BUILDING (Bid No. 25-19-04 ALPHA)

**WHEREAS**, the project Construction of Material Recovery Facility Building, an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Two Million Pesos (PHP2,000,000.00). A copy of the Certificate of Budget Allocation (CBA (CO) No. 25-02-264) dated 18 February 2025 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 25 March 2025 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*:

**WHEREAS**, the Invitation to Bid (ITB) was posted on 03 April 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 10 April 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*:

**WHEREAS**, the committee issued a Notice of Postponement dated 22 April 2025, rescheduling the Submission and Opening of Bids for this project. A copy of the Notice of Postponement is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 24 April 2025 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "F" & "G"*, respectively;

**WHEREAS**, the Bids and Awards Committee - Technical Working Group (BAC-TWG Alpha) issued its Bid Evaluation Report dated 28 April 2025 and was presented to the BAC on 06 May 2025. The BAC-TWG Alpha recommends the disqualification of Quin Sterling Construction, Inc. for tendering bids not in conformity with the Bill of Quantities and Detailed Estimates. The BAC-TWG Alpha also recommended for the declaration of failure of the said project and it was adopted by the committee. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "H" & "I"*, respectively;

**WHEREAS**, the committee issued a Notice of Disqualification to Quin Sterling Construction, Inc. dated 13 May 2025. A copy of the Notice of Disqualification is hereto attached as *Annex "I"*;

**WHEREAS**, Section 35.1 (c) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiation";

**NOW THEREFORE**, the CAAP-BAC ALPHA acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **CONSTRUCTION OF MATERIAL RECOVERY FACILITY BUILDING** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review.
