Invitation to Bid for "Supply, Delivery Installation and Commissioning of Cloud Web Application Firewall" Bid No. 25-37-05 Bravo

- The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP), through the CAAP
 Corporate Budget CY 2025 intends to apply the sum of FIFTEEN MILLION
 PESOS (Php15,000,000.00) being the ABC to payment under the contract for the
 Supply, Delivery, Installation and Commissioning of Cloud Web Application
 Firewall. Bids received in excess of the ABC shall be automatically rejected at the
 bid opening.
- 2. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES now invites bids for the above Procurement Project. Delivery of the Goods is required by **Sixty (60) Calendar Days**. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non- discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rulesand Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from CAAP Bids and Awards Committee Bravo and inspect the Bidding Documents at the address given below during Office Hours from 8AM to 5PM Philippine Time.
- 5. Upon payment of the bid documents, bidders must provide their respective email addresses to the BAC Secretariat. All communications, including but not limited to Notices, Resolutions, and Replies, among others, will be sent to the email address provided by the bidder/s. The date when such email was sent shall be considered the date of receipt of the bidder/s for purposes of complying with the requirements under RA 9184.
- 6. A complete set of Bidding Documents may be acquired by interested Bidders on 28 May 2025 until the deadline of submission of bid from the given address and upon payment of the applicable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php25,000.00 (exclusive)

of any and all taxes imposed by relevant government agencies). The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting the official receipt in person.

- The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference on 7. June 04, 2025 @ 9:30 AM through video conferencing or webcasting via Google Meet, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at 8. the office address indicated below on or before June 18, 2025 @ 9:30 AM. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and 9. in the amount stated in ITB Clause 14.
- Bid opening shall be on June 18, 2025 @ 9:30 AM at the given address below 10. and/or via Zoom/Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- The CAAP reserves the right to reject any and all bids, declare a failure of bidding, ornot award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
- Bidding Documents may also be downloaded free of charge from the website of 12. the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the BiddingDocuments not later than the submission of their bids.
