**WHEREAS**, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Supply and Delivery of Janitorial Supplies for the Month of April to June 2025 at Iloilo International Airport** in the PhilGEPS, CAAP Website and in conspicuous places at the premises of the Civil Aviation Authority of the Philippines with the ABC of **Nine Hundred Sixteen Thousand Three Hundred Eighty-Five Pesos (P 916,385.00)**;


