**RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID AND
RECOMMENDING APPROVAL FOR PREVENTIVE MAINTENANCE OF RUNWAY
PERIMETER FENCE AT KALIBO INTERNATIONAL AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Preventive Maintenance of Runway Perimeter Fence at Kalibo International Airport** in the PhilGEPS, CAAP Website and in conspicuous places at the premises of the Civil Aviation Authority of the Philippines with the ABC of **One Million Nine Hundred Ninety-Nine Thousand Three Hundred Eighty-Eight Pesos and 35/100 (₱ 1,999,388.35)**;

WHEREAS, the CAAP-Area VI BAC issued the BAC Resolution No. PB-KIA-2025-07-03 dated May 8, 2025, declaring a short of award for the project **Preventive Maintenance of Runway Perimeter Fence at Kalibo International Airport** to **EC BUILDERS** due to the election ban in effect at that time according to 4.1 of the Circular 01-2024 dated 18 December 2024 of the Government Procurement Policy Board (GPPB);

WHEREAS, the election ban that necessitated the declaration of a short of award has since been lifted and that **EC BUILDERS** remains the bidder as the Single Calculated Responsive Bid for the project, as determined during the initial stages of the procurement process;

WHEREAS, the CAAP-Area VI BAC desires to proceed with the completion of the procurement process and award the Project to **EC BUILDERS**;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the continuation of the procurement process for the project **Preventive Maintenance of Runway Perimeter Fence at Kalibo International Airport** following the lifting of the election ban;
- b) To recommend the award for the project **Preventive Maintenance of Runway Perimeter Fence at Kalibo International Airport** to **EC BUILDERS** as the Supplier with the Lowest Calculated Responsive Bid with the bid amount of **One Million Nine Hundred Eighty-Nine Thousand Two Hundred Eighty-One Pesos and 64/100 (₱ 1,989,281.64)**; and
- c) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
