



BAC Resolution No. 2025-0311-21 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, REPAIR OF FREQUENTIS VOICE COMMUNICATION SYSTEM MODULES FROM PHILIPPINE ATM CENTER AT MANILA CNS/ATM FACILITY

WHEREAS, the project, Repair of Frequentis Voice Communication System Modules from Philippine ATM Center at Manila CNS/ATM Facility, an ANS project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Sixteen Million Four Hundred Thousand Pesos (PHP16,400,000.00). A copy of the Certificate of Budget Allocation CBA (CO) No. 25-02-241 dated 14 February 2025 is herein attached as *Annex "A"*;

WHEREAS the Change/Determination of Mode was conducted on 28 March 2025 where the end-user requested for the Confirmation of Mode of Procurement be done through Direct Contracting stating the fact that there is only one service provider for the project a position substantiated by the submitted Certificate of Sole and Exclusive Proprietorship, after reviewing the documents the Committee concurred. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Notice of Direct Contracting and Request for Quotation dated 05 April 2025 to AirNav Technology Services Inc. A copy of the Notice of Direct Contracting and Request for Quotation is hereto attached as *Annex "C"*;

WHEREAS, the Submission and Opening of bids for the project was held on 11 April 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "D" & "E", respectively*;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 21 April 2025. On the same date, the BAC-Bravo TWG presented its report indicating that AirNav Technology Services Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 31.2 of RA 12009. When it is sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **Repair of Frequentis Voice Communication System Modules from Philippine ATM Center at Manila CNS/ATM Facility** in the total amount of **Fourteen Million Five Hundred Seventy-Six Thousand Pesos (PHP14,576,000.00)** to **AirNav Technology Services Inc.;**
