- 2. Number of days to complete: Thirty (30) Calendar Days
- 3. Bid must be complete and award will be made on a lump sum basis.
- 4. Price validity shall be for a period of thirty (30) calendar days.
- 5. The following should be submitted together with the quotation:
 - 5.1 Current Mayor's/Business Permit;
 - 5.2 Phil-GEPS Registration Number;
 - 5.3 List of completed similar contracts within the last five (5) years which must be related to repair of HVAC (Heating, Ventilation & Air-Conditioning System) or any chiller & air handling repair works with attached supporting documents;
 - 5.4 List of Contractor's Equipment, including proof of ownership or certification of availability of Gauge Manifold, Recovery Tanks, Multimeter, Basic Tools and Special Tools, from the lessor/vendor for the duration of the project, as the case may be;
 - 5.5 Name/credentials of proposed one (1) Mechanical/Electrical Engineer, two (2) Service Technician and one (1) Helper;
- 6. Other documentary requirements:
 - 6.1 Omnibus Sworn Statement

6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and

6.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; List of completed similar contracts; List of Contractor's Equipment and Name/credentials of proposed personnel, shall be automatically disqualified.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **Online submission is not allowed and late quotations shall not be accepted.**

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded. Quotations must be delivered to the Civil Aviation Authority of the Philippines, Area Center V at its physical address at the BAC/CCC Office, Ground Floor Admin Bldg., Bicol International Airport, Daraga, Albay not later than 02:00 p.m. on 27 May 2025.
