 - 5.4 List of completed similar project within the last three (3) years which must be related to any vertical or horizontal works with attached supporting documents;
 - 5.5 Name/credentials of proposed one (1) Safety Officer and one (1) Construction Foreman;
6. Other documentary requirements:
 - 6.1 Omnibus Sworn Statement

Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; Valid PCAB License; List of completed similar contracts; and Name/credentials of proposed personnel, shall be automatically disqualified.


