- 4. List of completed similar project within the last three (3) years which must be related to any aerodrome works located at airside with attached supporting documents;
- Name/credentials of proposed one (1) Safety Officer and one (1) Construction Foreman;
- 6. Other documentary requirements:
 - 6.1. Omnibus Sworn Statement

(see attached format, maybe submitted together with the quotation or before issuance of Notice of Award.)

Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; Valid PCAB License; List of completed similar contracts; and Name/credentials of proposed personnel, shall be automatically disqualified.
