 - List of completed similar contracts within the last three (3) years which must be related 5.3 to preventive maintenance of air-cooled chiller and chilled water pumps with attached supporting documents;
 - Name/credentials of proposed one (1) Mechanical/Electrical Engineer, one (1) Technical Personnel and Two (2) Helper;
 - Proof/permit showing that its primary business is on Operation and Maintenance of aircooled chiller and chilled water pumps with at least three (3) years of experience; and
