For

SUPPLY/DELIVERY OF SPARE PARTS FOR JOTRON VHF AM RADIO FOR VARIOUS ANF'S

and

EVERCON BUILDERS & EQUIPMENT CORPORATION, a corporation organized and existing by virtue of law and with office address at Unit 3A, 644, Rajah Matanda Street, Manila 1012, Philippines hereinafter called "the Supplier" and represented herein by **MARIO ONG** in his capacity as President of the other part.

WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the *Supply/Delivery of Spare Parts for Jotron VHF AM Radio for various ANF's* and has accepted the Bid by the Supplier for the supply of those goods in the sum of THREE MILLION NINE HUNDRED FORTY-EIGHT THOUSAND EIGHT HUNDRED EIGHTY PESOS ONLY (Php3,948,880.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively as
- assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

 - (2.2) Change/Determination of Mode dated 07 March 2025
 - (2.3) Notice of Direct Contracting & Request for Quotation dated 07 March 2025
 - (2.4) Opening of Bids dated 21 March 2025
 - (2.5) Eligibility Requirements/ Financial Component & Technical Component
 - (2.6) BAC TWG (Bravo) Bid Evaluation Report dated 26 March 2025
 - (2.7) BAC Resolution No. 2025-0311-13 (Bravo) dated 31 March 2025
 - (2.8) Notice of Award dated 31 March 2025
- 3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within **One Hundred Eighty (180) Calendar Days** from receipt of the Notice to Proceed and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may

become payable under the provisions of the contract at the time and in the manner prescribed by the *Agreement*.

5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
