In lieu of the assigned Project Manager with PMP (Project Management Professional) certification, we propose the following as equivalent proof of project management expertise.</p> <ul style="list-style-type: none"><li>▪ An employed Project Manager with a valid license as a Professional Electronics Engineer (PECE) issued by the Professional Regulation Commission (PRC).</li><li>▪ An employed Project Manager with at least 20 years of experience in Project Management in the Construction Industry, supported by a Certification from the Human Resources Department, duly signed by the HR Manager.</li></ul>	<p>In lieu of a Project Manager with a Project Management Professional (PMP) certification, <b>a Project Manager holding a valid license as a Professional Electronics Engineer (PECE) issued by the Professional Regulation Commission (PRC) shall be accepted.</b></p>
<p>2. In lieu of the NTC Value-Added Service (VAS) Certification, we propose submission of a:</p>	<p><b>Bidders must comply with the required Value-Added Service (VAS) License issued by the</b></p>

<ul style="list-style-type: none"> <li>▪ Certification from the CCTV Manufacturer confirming that our company is authorized and certified to supply, design, install, and support the CCTV system of the brand we are offering.</li> </ul>	<p><b>National Telecommunications Commission (NTC), in accordance with NTC Memorandum Circular No. 02-05-2008. This is essential as the CAAP Command Center will host sensitive security data and integrate airport surveillance through a centralized network infrastructure.</b></p>
<p>3. In lieu of registration with the National Privacy Commission (NPC) for compliance with the Data Privacy Act, we submit a:</p> <ul style="list-style-type: none"> <li>▪ Certification from the CCTV Manufacturer affirming that the offered CCTV system is compliant with international data privacy and security standards, ensuring protection of personal data in accordance with global security policies.</li> </ul>	<p><b>This is a government-mandated requirement in compliance with the Data Privacy Act of 2012 (RA 10173) that all companies must adhere, and thus, this project retains this requirement.</b> This project specifically involves the procurement and deployment of a Closed-Circuit Television (CCTV) system, which inherently entails the collection, processing, and potential storage of personal data, including images and behavioral patterns of individuals within the secured premises.</p>
<p>4. In lieu of company-level ISO 9001 (Quality Management) and ISO 27001 (Information Security) certifications, we offer:</p> <ul style="list-style-type: none"> <li>▪ A Manufacturer Certification stating that the CCTV brand and system being offered is produced by an ISO 9001 and ISO 27001 certified company, thereby meeting international quality and information security standards.</li> </ul>	<p>ISO 27001:2022 (Information Security Management) is a mandatory requirement aligned with CAAP's data privacy and information security policies for all IT and security-related projects. However, for ISO 9001:2015 (Quality Management), considering that bidders typically do not manufacture the security equipment themselves, an ISO 9001:2015 Certification from the CCTV Product Manufacturer shall be accepted.</p>



	<b>Revised Requirement:</b>  <b>The Bidder must have ISO 27001:2022 Certification and submit an ISO 9001:2015 Certification from the CCTV Product Manufacturer.</b>
