**SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PURCHASE AND DELIVERY OF ELECTRONIC TERRAIN AND OBSTACLE DATA (ETOD) AREA 2A AND 2B INCLUDING ONE (1) WORKSTATION (LAOAG, PUERTO PRINCESA, ILOILO AND KALIBO)**

**WHEREAS**, the project, Purchase and Delivery of Electronic Terrain and Obstacle Data (ETOD) Area 2A and 2B including One (1) Workstation (Laoag, Puerto Princesa, Iloilo and Kalibo), an ODG-AISG/CORPLAN project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Forty-Five Million Pesos (PHP45,000,000.00). A copy of the Certificate of Budget Allocation CBA (CO) No. 25-02-170 dated 05 February 2025 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 26 February 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 14 March 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, Bid Bulletin No. 01 published 19 March 2025 was issued for some clarifications, revisions or amendments in the Bidding Documents. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "D"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 21 March 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "E"*;

**WHEREAS**, the Committee received a letter of inquiry dated 21 March 2025, from Filsite Mapping Solutions suggesting a counter proposal to the Technical Specifications listed by the end user for procurement. A copy of the letter of inquiry is hereto attached as *Annex "F"*;

**WHEREAS**, the Committee received a letter requesting the formal review of the requirement for the Single Largest Completed Contract dated 27 March 2025, from RASA Surveying and Realty. A copy of the request letter is hereto attached as *Annex "G"*;



**WHEREAS**, Bid Bulletin No. 02 published 28 March 2025 was issued for some clarifications, revisions or amendments in the Bidding Documents. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "H"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 07 April 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "J" & "K", respectively*;



**WHEREAS**, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 02 May 2025 and was presented to the BAC on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of Geo Spectrum Marketing Services in Joint Venture with RAJ Laurente Construction and Development Philippines be declared as the Lowest Calculated & Responsive Bid (LCRB) and that the contract be awarded to the bidder in the amount of Thirty-Eight Million Four Hundred Thirty-Six Thousand Six Hundred Twenty-Five Pesos & 52/100 (PHP38,436,625.52).
