**DECLARATION OF BERBEN MERCHANT, INC. AS THE LOWEST CALCULATED
RESPONSIVE BIDDER (LCRB) AND RECOMMENDATION TO AWARD THE CONTRACT:
"COMPREHENSIVE PEST CONTROL OF ALL DIA BUILDINGS"**

WHEREAS, the Civil Aviation Authority of the Philippines – Area XI posted in PhilGEPS and advertised continuously in three (3) conspicuous places for seven (7) calendar days, the Invitation to Bid of "COMPREHENSIVE PEST CONTROL OF ALL DIA BUILDINGS";

WHEREAS, as indicated in the advertisement, the pre-bidding conference was held on April 11, 2025 via online which was followed by the opening of bids on April 23, 2025 at CAAP-Davao International Airport;

WHEREAS, on the day of the opening of bids for the said project, two bidders namely, MAPECON PHILIPPINES, INC. and BERBEN MERCHANT, INC. submitted their bid documents on or before the deadline of submission/dropping of bids.

WHEREAS, the result of the initial evaluation for the eligibility of the bids is shown in the table below:

WHEREAS, the bid of the eligible bidder(s) underwent the process of Detailed Bid Evaluation held on April 25, 2025;

WHEREAS, the Bid Evaluation Report showed that the bid of BERBEN MERCHANT, INC. was found to be complete and compliant and was declared as the Lowest Calculated Bid (LCB) through BAC Resolution No. 2024-10 dated April 25, 2025;

WHEREAS, Section 34.1 of the 2016 Revised IRR of RA 9184 states that, *"The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents."*;

WHEREAS, upon declaration of the Lowest Calculated Bid, the bid of BERBEN MERCHANT, INC. was post-qualified within 14 CD from April 25-May 8, 2025;

WHEREAS, the Post-qualification Report dated May 13, 2025 validated with a finding that BERBEN MERCHANT, INC. is the Lowest Calculated Responsive Bidder and was recommended for award through Post-qualification Report Overall Findings and Recommendation;
