



BAC Resolution No. 2025-0311-16 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PROCUREMENT OF DISASTER RECOVERY SYSTEM (DRS) FOR THALES TOPSKY-HE AIR TRAFFIC MANAGEMENT SYSTEM (ATMS) FOR THE PHILIPPINE AIR TRAFFIC MANAGEMENT CENTER (ATMC)

WHEREAS, the project, Procurement of Disaster Recovery System (DRS) for Thales Topsky-HE Air Traffic Management System (ATMS) for the Philippine Air Traffic Management Center (ATMC), an ANS project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of One Hundred Ninety-Eight Million Pesos (PHP198,000,000.00). A copy of the Certificate of Budget Allocation CBA (CO) No. 25-02-249 dated 17 February 2025 is herein attached as *Annex "A"*;

WHEREAS the Change/Determination of Mode was conducted on 12 March 2025 where the end-user requested for the Confirmation of Mode of Procurement be done through Direct Contracting stating the fact that there is only one service provider for the project a position substantiated by the submitted Certificate of Sole and Exclusive Proprietorship, after reviewing the documents the Committee concurred. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Notice of Direct Contracting and Request for Quotation dated 12 March 2025 to Thales Australia Limited. A copy of the notice is hereto attached as *Annex "C"*;

WHEREAS, Bid Bulletin No. 01 dated 19 March 2025 was issued for the new schedule of the Submission and Opening of Bids of the Project. A copy of Bid Bulletin No. 01 is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 28 March 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 02 April 2025. On the same date, the BAC-Bravo TWG presented its report indicating that Thales Australia Limited. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 50.c of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H"*, respectively;

WHEREAS, Section 50 of RA 9184 *it provides that Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:*

Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **Procurement of Disaster Recovery System (DRS) for Thales Topsky-HE Air Traffic Management Systeme (ATMS) for the Philippine Air Traffic Management Center (ATMC)** in the total amount of **One Hundred Ninety-Seven Million Pesos (PHP197,000,000.00)** to **Thales Australia Limited.;**


