The Civil Aviation Authority of the Philippines (CAAP) through its Bids and Awards Committee intends to apply the sum **One Million three Hundred Sixty-Seven Thousand Seven Hundred Pesos Only (₱1,367,700.00)**, inclusive of all applicable government taxes, fees, and charges, being the Approved Budget for the Contract (ABC) to payments under the contract for the project, **Supply and Delivery of Spare Parts for Rohde & Schwarz Communication Equipment for Laguindingan and Philippine ATMC.**
