DECLARATION OF <u>AIR PROSYSTEMS, INC.</u> AS THE LOWEST CALCULATED RESPONSIVE BIDDER (LCRB) AND RECOMMENDATION TO AWARD THE CONTRACT: "SUPPLY AND DELIVERY OF FLOOR MOUNTED AIRCON INVERTER PBB NO. 3,4,5 AND 6 WITH INSTALLATION"

WHEREAS, the Civil Aviation Authority of the Philippines – Area XI posted in PhilGEPS and advertised continuously in three (3) conspicuous places for seven (7) calendar days, the Invitation to Bid of "SUPPLY AND DELIVERY OF FLOOR MOUNTED AIRCON INVERTER PBB NO. 3,4,5 AND 6 WITH INSTALLATION";

WHEREAS, as indicated in the advertisement, the pre-bidding conference was held on April 11, 2025 via online which was followed by the opening of bids on April 23, 2025 at CAAP-Davao International Airport;

WHEREAS, on the day of the opening of bids for the said project, five (5) bidders namely the following:

- 18 DEGREES AIR COOLING SOLUTIONS INC.;
- TRUE-TEMP CORPORATION;
- 4. FTPONTILLO BUILDERS AND ENGINEERING SERVICES; and
- EMCOR, INC.

submitted their bid documents on or before the deadline of submission/dropping of bids.

WHEREAS, the Bid Evaluation Report showed that the bid of AIR PROSYSTEMS, INC. was found to be complete and compliant and was declared as the Lowest Calculated Bid (LCB) through BAC Resolution No. 2024-07 dated April 25, 2025;

WHEREAS, Section 34.1 of the 2016 Revised IRR of RA 9184 states that, "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification in order to determine whether the bid for concerned complies with and is responsible to all the requirements and conditions as specified in the Bidding Documents.";

WHEREAS, upon declaration of the Lowest Calculated Bid, the bid of AIR PROSYSTEMS, INC. was post-qualified within 13 CD from April 26-May 8, 2025;

WHEREAS, the Post-qualification Report dated May 13, 2025 validated with a finding that AIR PROSYSTEMS, INC. is the Lowest Calculated Responsive Bidder and was recommended for award through Post-qualification Report Overall Findings and Recommendation;

NOW, THEREFORE, for and in consideration of the foregoing premises, be it RESOLVED, as it hereby RESOLVED, to declare AIR PROSYSTEMS, INC. as the Lowest Calculated Responsive Bidder (LCRB) with a bid amounting to SEVEN HUNDRED FIFTY-SIX THOUSAND ONE HUNDRED SEVENTY PESOS ONLY (Php 756,170.00) and is hereby recommended for Award for the Contract of: "SUPPLY AND DELIVERY OF FLOOR MOUNTED AIRCON INVERTER PBB NO. 3,4,5 AND 6 WITH INSTALLATION"
