WHEREAS, the Civil Aviation Authority of the Philippines – Area XI posted in PhilGEPS and advertised continuously in three (3) conspicuous places for seven (7) calendar days, the Invitation to Bid of "TIRES FOR OSHKOSH FIRETRUCKS";

WHEREAS, as indicated in the advertisement, the pre-bidding conference was held on April 11, 2025 via online which was followed by the opening of bids on April 23, 2025 at CAAP-Davao International Airport;

WHEREAS, on the day of the opening of bids for the said project, two bidders namely, <u>ALJON INTERNATIONAL CORPORATION</u> and <u>PHILTYRES CORPORATION</u> submitted their bid documents on or before the deadline of submission/dropping of bids.

WHEREAS, the result of the initial evaluation for the eligibility of the bids is shown in the table below:

WHEREAS, the Bid Evaluation Report showed that the bid of <u>ALJON INTERNATIONAL</u> <u>CORPORATION</u> was found to be <u>complete and compliant</u> and was declared as the Single Calculated Bid (SCB) through BAC Resolution No. 2024-05 dated April 25, 2025;

WHEREAS, Section 34.1 of the 2016 Revised IRR of RA 9184 states that, "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents.";

WHEREAS, upon declaration of the Single Calculated Bid, the bid of ALJON INTERNATIONAL CORPORATION was post-qualified within 14 CD from April 25-May 8, 2025;

WHEREAS, the Post-qualification Report dated May 13, 2025 validated with a finding that ALJON INTERNATIONAL CORPORATION is the Single Calculated Responsive Bidder and was recommended for award through Post-qualification Report Overall Findings and Recommendation;

NOW, THEREFORE, for and in consideration of the foregoing premises, be it RESOLVED, as it hereby RESOLVED, to declare ALJON INTERNATIONAL CORPORATION as the Single Calculated Responsive Bidder (SCRB) with a bid amounting to FOUR MILLION THREE HUNDRED FORTY-FIVE THOUSAND SIX HUNDRED PESOS ONLY(Php 4,345,600.00) and is hereby recommended for Award for the Contract of:
